AB 22	McCarty	California Longitudinal Pupil Achievement Data System: data collection. AB 92	Reyes	Would amend existing law pertaining to family fees for childcare and development services. Among other things, would require family fees to not exceed 1% of the family's monthly income. Would require the lead agency to convene a workgroup of [stakeholders] to develop an equitable fee schedule. Would require CDE to create a report with the proposed fee schedule, the names and association of stakeholders, and the criteria use to develop the fee schedule. Would exempt families with an adjusted monthly family income below 75% of the State Median Income (SMI) from family fees. Would waive family fees for all families until 10/31/23.
